

# Give Big at the Park: Meet & Greet Day Facility Use Details & Agreement

Please read the following terms of agreement carefully before registering for the event:



## Event Details

- **Date:** Saturday, April 20, 2024
- **Time:** Set up begins at 7 AM; Tear down must be completed by 2 PM
- **Event Time:** 8 AM – 1 PM
- **Location:** The Park at River Walk; 11200 Stockdale Hwy. Bakersfield, CA 93311
- The event will happen RAIN or SHINE
- Additional instructions about safety/logistics, e.g., parking, food/snack purchase options available at the park, precautions against sun and wind, etc., will be provided the week of April 15, along with booth location assignments.

## Organizations Responsibilities

- **Organizations must bring their own table, chairs, and pop-ups** (if shade is desired) and set up in the spot that will be assigned to them. Electrical outlets are **NOT** available.
- Organizations are responsible for securing and disposing of their own trash.
- Organizations have until April 7, 2024, to register or cancel.
- Nonprofits and volunteers must park in the suggested parking areas. A designated unloading and loading area will be provided for equipment and supplies. A map will be provided closer to the event date.
- Giveaways, raffles, park toys and recreational equipment are encouraged.

## General Rules

- No vehicles will be allowed on the grass.
- No glass bottles/ containers allowed in City Parks. No alcohol consumption in parking lot.
- State law prohibits any person from smoking within 25 feet of any playground or tot lot sandbox.
- No animals besides house pets (dogs, cats) are allowed to be brought to the park.

## Liability and Indemnification

Kern Community Foundation requires that users insure against liability arising from their use. Applicant agrees to indemnify, hold harmless and defend Kern Community Foundation, and each of its officers, officials, employees, volunteers and agents from any and all loss, liability, fines, penalties, forfeitures, costs and damages (whether in contract, tort or strict liability including but not limited to personal or bodily injury, death at any time and property damage) incurred by Kern Community Foundation, the applicant or any other person and from any and all claims, demands and actions in law or equity (including attorney's fees and litigation expense), arising or alleged to have arisen directly or indirectly out of this permit or the use of this facility.

Kern Community Foundation will not be liable for any loss or damage to your equipment. The organization listed on this contract shall reimburse Kern Community Foundation for damages to buildings, grounds and/ or equipment arising from your use; normal wear is excluded.
